TERMS & CONDITIONS

AVON TOP SELLERS CLUB

- 1. This programme is open to all new and existing Independent Representatives.
- 2. This incentive runs from January 2018 to December 2018 inclusive.
- 3. All Independent Avon Representatives, excluding those Representatives who are also Avon employees, temporary workers, agency staff or contractors, are eligible to participate in this incentive. If you do not meet the criteria specified then your participation will not be deemed valid.
- 4. You many not purchase on another Sales Leaders/Representative's account.
- 5. Purchases of discontinued products do not qualify for the programme and should the company become aware of purchases of such products, the company shall have the discretion to disqualify you from the programme.
- 6. Any late orders not invoiced or released by December 2018 close-off will not count towards your 2018 sales goal. The exact date of close-off will be communicated in 2018.

- 11. The Representative account details held by Avon are final and will be used to measure the results.
- 12. Top Sellers Club status achieved in 2018 will carry the associated benefits into the following year. i.e. up to the end of December 2019.

- 13. The cost of any goods ordered that are not available will not be added your Personal Brochure Sales. Where product supply levels deteriorate substantially Avon may, at its absolute discretion, consider waiving this condition as a gesture of goodwill.
- 14. All returned products will be credited to the Representative's Avon account and deducted from the Personal Brochure Sales total in the month of claim.
